

**Ingham County Genealogical Society  
General Membership Meeting  
November 13, 2014**

The November 13, 2014, regular Membership meeting of the Ingham County Genealogical Society (ICGS) was held at the Vevay Township Hall, Mason, Michigan. President Diane Bishop called the meeting to order at 7:00 p.m. There were 23 members in attendance.
